Application For Litter Registration

Please include the following with the Application:

A. Sire and Dam are Miniature Australian Shepherd Club of America (MASCA) registered:

1. A copy OFA and CERF certificate(s) on sire and dam, if available, and title certificate(s), if you wish title(s) to be included on future pedigrees.
2. Registration fee (see Page 2 of Application.) Membership fees are in addition to Registration Fees.

B. Either Sire or Dam is NOT MASCA registered but registered as an Australian Shepherd or Australian Shepherd of the miniature size with: ASCA, AKC, IMASC, ASDR, NSDR Canadian, CKC Canadian Kennel Club:

1. A copy of the non-MASCA registered dog's: NSDR Canadian, ASDR, ASCA, CKC Canadian Kennel Club, AKC Australian Shepherd registration, IMASC certificate(s)
2. 3 photographs of the non-MASCA registered dog: 2 in standing position left side and right side, front.
3. A copy OFA and CERF certificate(s) on sire and dam, if available, and title certificate(s), if you wish title(s) to be included on future pedigrees.
4. Registration fee (see Page 2 of Application.) Membership fees are in addition to Registration fees.

C. Both Sire and Dam and not MASCA registered, the litter is not eligible for registration. One or both parents must be registered with MASCA through an Individual Dog Registration or the Hardship Registration.

D. Age Requirements:

1. Sire and dam must be (12) months or older on date of mating to register the litter with Full Registration Privileges.
2. Sire and Dam are at least nine (9) months or older on the date of mating, the litter is registered with Provisional Registration Privileges. A Provisionally Registered dog with hip and eye clearances at two (2) or more years of age can be given a Full Registration certificate by paying a \$50 Change of Registration Fee. A Provisionally Registered dog may compete in all MASCA events.
3. Sire and/or Dam are not nine (9) months or older on date of mating, the litter cannot be registered.

E. Litter Owner:

The recorded Owner(s) or Lessee(s) of the Dam at the time of whelp is the Litter Owner. Leases must be on file with MASCA before the Litter Application is Received/Recorded.
